本會簡介

Brief Introduction

成立於 1956 年的香港拯溺總會是一個非政府的志願組織，它不單為國際救生總會之全資格會員，更是其「創會會員」。60 多年來，香港拯溺總會本著「天下有溺者，由己溺之也」的創會精神，致力推廣拯溺工作，發揚救己救人的互助精神，教育廣大香港市民認識水上安全的重要性。時至今日，本會會員合共曾救回超過 33,772 條寶貴性命，愛心遍及全港，吸引不少熱心人士加入，屬會會籍現已增長逾一百多個，活躍會員更超過 10,000 人。

本會是香港唯一認可的拯溺考試機構，肩負全港拯溺考試的評核工作。在各首長及執委會領導下，加上屬會積極推動，令拯溺活動得以廣泛宣揚，市民有機會認識及參與這項極具意義的運動，使拯溺救生的工作得到社會各界認同。

近年來，本會的任務更趨多元化，除努力提升救生員的資格以達致國際水平外，亦不斷引入嶄新及優秀的拯溺技術，如水上電單車拯救、快艇拯救、水上急救、自動體外心臟去纖維性顫動法、手力急救、競賽教練及國際裁判訓練等，多年來的努力已吸引各國救生組織及本地精英參加，使這些世界頂尖的拯溺技術得以發展及宣揚。

The Hong Kong Life Saving Society, formerly known as "The Hong Kong Life Guard Club", is a voluntary organization established in 1956. It is not only a full member but also a Founder Member of the International Life Saving Federation (ILS). Over the past sixty years, the mandate of the Society is continuously carried out by many dedicated volunteers bound to serve not only the Society but their fellow men, under the common motto "Whomsoever you see in distress, recognize in him a fellow man". Aiming at combating aquatic-related accidents, the Society encourages everyone to participate in advocating water safety, life saving training, examinations and competitions so as to arouse the public awareness on water safety. Hitherto over 33,772 lives were saved by our lifesavers, and there are more than one hundred affiliated clubs and over 10,000 persons involved actively.

The Society is the sole organization that conducts lifesaving examinations and awards credentials in Hong Kong. Our awards are widely recognized by government and the private sector. Under the guidance of our Council Members and Executive Committee, affiliated clubs work enthusiastically, resulting in the well organized lifesaving training and renowned respects from the community.

Over the past decade, the Society's work becomes more diversified. Apart from the success of lifeguarding standard upgrade, most latest lifesaving techniques would be developed and promoted, such as Jet Ski Rescue, IRB Rescue, Aquatic First Aid, AED, Acupressure First Aid, Competition Coach and International Referee Training, etc. which attracted many overseas and local lifesavers to participate.

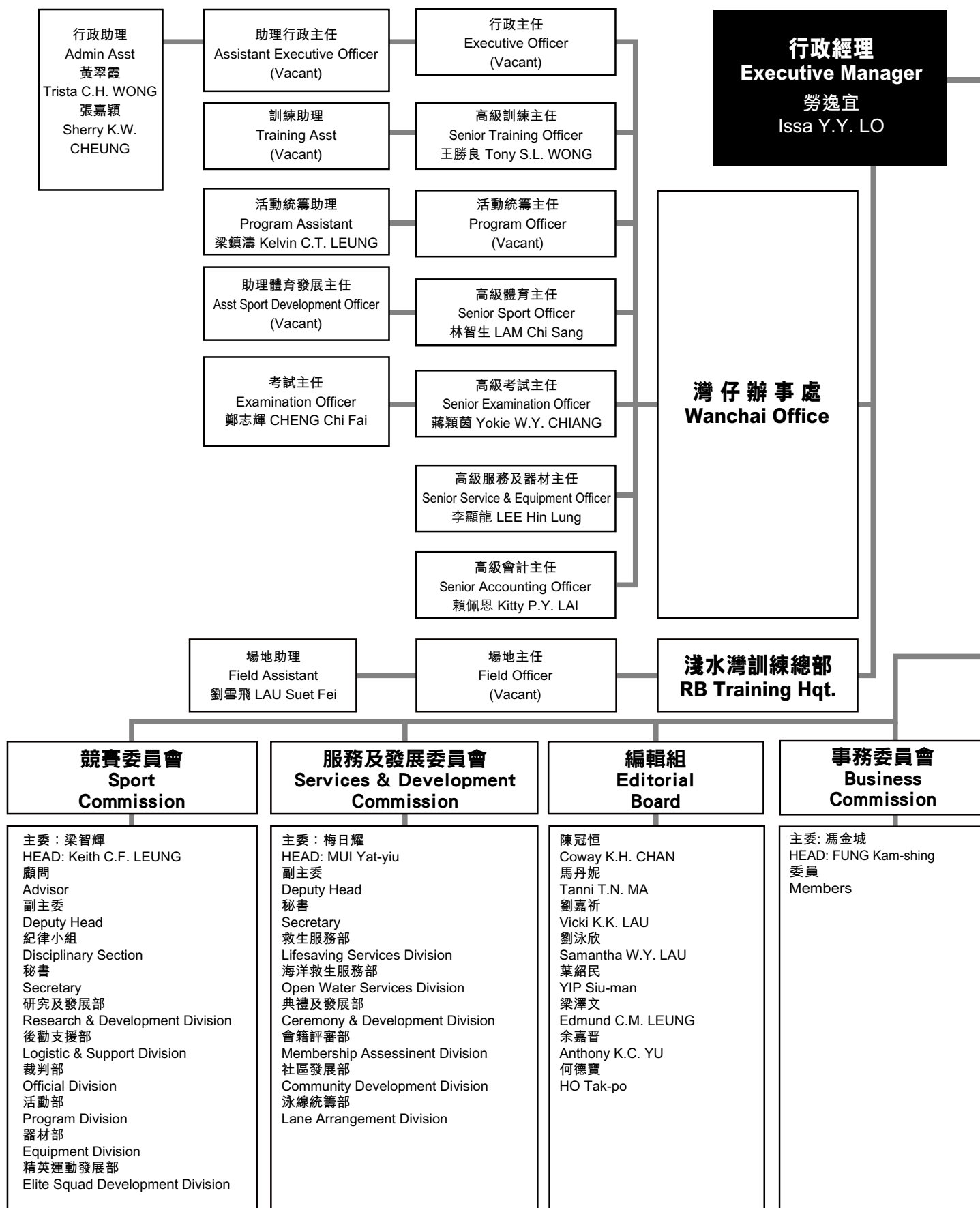

2021/22 年度，隨著香港疫情漸趨穩定，本會的訓練、考試及活動亦續漸恢復，而且亦參與了一些大型賽事，並取得相當優異的成績。縱然疫情未完全消退，但本會仍會上下一心，秉承著本會的創會精神 -- 「天下有溺者，由己溺之也。」，繼續推動本港的拯溺運動，把拯溺救生推廣至市民大眾。

2021 International Pool Meeting

香港拯溺隊於 2021 年 11 月在比利時舉行的「International Pool Meeting」賽事中取得 2 金 5 銀佳績，其中陳芷晴、李穎欣、陳穎臻、司徒詠珈於女子 4x25 公尺運送假人接力賽更以破香港紀錄成績奪得是次賽事的銀牌。此外，在是次賽事中有 4 個項目的比賽成績達到世界運動會的參賽標準，當中包括：女子 200 公尺游泳障礙賽、女子 4x25 公尺運送假人接力賽、女子 4x50 公尺混合接力賽及男子 100 公尺穿蛙鞋運送假人賽。

綜合拯溺證書訓練計劃 (泳池救生及沙灘救生) 2021/22

2021/22 年度，本會繼續舉辦「綜合拯溺證書訓練計劃 (泳池救生及沙灘救生)」，以推動拯溺的發展，並提升本港拯溺的專業技術，藉以提高大眾水上安全的水平。計劃歡迎年齡 16 歲或以上，有興趣參與拯溺的人士參加。是次計劃得到各屬會積極參與，泳池救生章有 35 班，共 492 人參加，沙灘救生章有 10 班，共 141 人參加。

拯溺競賽運動證書訓練計劃 (救生小鐵人 / 拯溺競賽初級證書) 2021/22

2021/22 年度，本會恢復舉辦「拯溺競賽運動證書訓練計劃 (救生小鐵人 / 拯溺競賽初級證書)」，目的是提供初階的拯溺競賽訓練課程，以循序漸進的方式提升學員技術水平，藉以推廣拯溺競賽運動予兒童及青少年參與，提高大眾水上安全的意識，為競賽運動培育新血。此計劃歡迎年齡 7 歲或以上人士參加。計劃包括了新系列的救生小鐵人金、銀、銅證書及拯溺競賽初級證書，讓各屬會可有效推動競賽運動，培育幼苗，對拯溺運動之推廣定下了基礎的框架。在屬會之踴躍參與下，本年度共有 8 班金、銀、銅章救生小鐵人訓練班，共有 64 人參加，而拯溺競賽初級證書訓練班有 6 班，共 48 人參加。

In 2021/22, most training, examination and the related activities of The Hong Kong Life Saving Society (the Society) resumed eventually amid stabilization of the COVID-19 pandemic. With the concerted efforts and support of all officials and members of the Society, we have achieved a brilliant result in the International Lifesaving Event. Under the motto of the Society – “Whomsoever you see in distress, recognize in them a fellow human being”, we continuously pledge to serve the community to the best of our capabilities with active participation of our enthusiastic voluntary members.

2021 International Pool Meeting

The HK team has won 2 Gold and 5 Silver medals in the International Pool Meeting which was held on 13 November 2021 in Belgium. In addition, the HK women team members CHAN Tsz-ching, LI Alexandra, CHAN Wing-chun and SZETO Wing-ka won the 1st runner-up of Women 4x25 Manikin Relay. They also broke the HK record. Meanwhile, 4 events attained the qualifying time of the World Games requirements. i.e. Women 200M Obstacle Swim, Women 4x25 Manikin Relay, Women 4x50M Medley Relay & Man 100 M Manikin Carry with Fins.

Annual General Lecture 2022 (Cancelled)

The Annual General Lecture and Awards Presentation Ceremony, originally scheduled on March 2022 at the Jockey Club Lecture Theatre of the Olympic House, was called off due to COVID-19 epidemic. For details of the award recipients, please refer to the Chinese Version of the Secretariat Report.

Integrated Lifesaving Certificate Training Scheme (Pool Lifeguard and Beach Lifeguard) 2021/22

In 2021/22, the Society continued to organize the “Integrated Lifesaving Certificate Training Scheme (Pool Lifeguard and Beach Lifeguard)” with the aim of enhancing the overall standard of lifesaving and water safety. Those who are interested in lifesaving aged 16 or above are welcome to join the Scheme. With the support of our affiliated clubs, thirty-five Pool Lifeguard Award courses were held with 492 participants enrolled. Another ten Beach Lifeguard Award courses were also conducted with 141 participants enrolled in this Scheme.

Lifesaving Competition Sport Certificate Training Scheme (Lifesaving Ironkids / Lifesaving Competition Basic Certificate) 2021/22

In 2021/22, the Society organized the “Lifesaving Competition Sport Certificate Training Scheme (Lifesaving Ironkids / Lifesaving Competition Basic Certificate)”. The objective of the scheme is to provide basic lifesaving competitive sport training in accordance with systematic program to enhance participants’ skill level, and also provide opportunity for juveniles to participate, increase their water safety awareness, as well as increase the number of participants in lifesaving sports. Participants of 7 years old or above are welcome to join the Scheme. Certificates of Lifesaving Ironkid Gold, Silver, and Bronze Awards and Lifesaving Competition Basic Certificate would be issued under the scheme. With the enthusiastic response from affiliated clubs, this year we held 8 courses of Lifesaving Ironkid Gold, Silver, and Bronze Awards with 64 participants and 6 courses of Lifesaving Competition Basic Certificate with 48 participants joined.

Conclusion

2021/22 was a year full of challenges. Fortunately, we have received strong support from affiliated club members, government departments, and sponsorship from the Presidents and Councilors. With the staunch support from all stakeholders, we are able to complete our activity plans and activities timely. Looking forward the Society would continue to introduce advanced life-saving techniques training keeping pace with the latest development of the directives of the International Life Saving Federation with a view to nurturing more qualified lifesavers and talented athletes for Hong Kong.

5. 檢討拯溺考試制度流程及報考程序。
6. 檢討及更新 " 施救員訓練手冊 "。
7. 香港拯溺總會成功向國際救生總會申請批准泳池救生章達到其泳池救生標準。

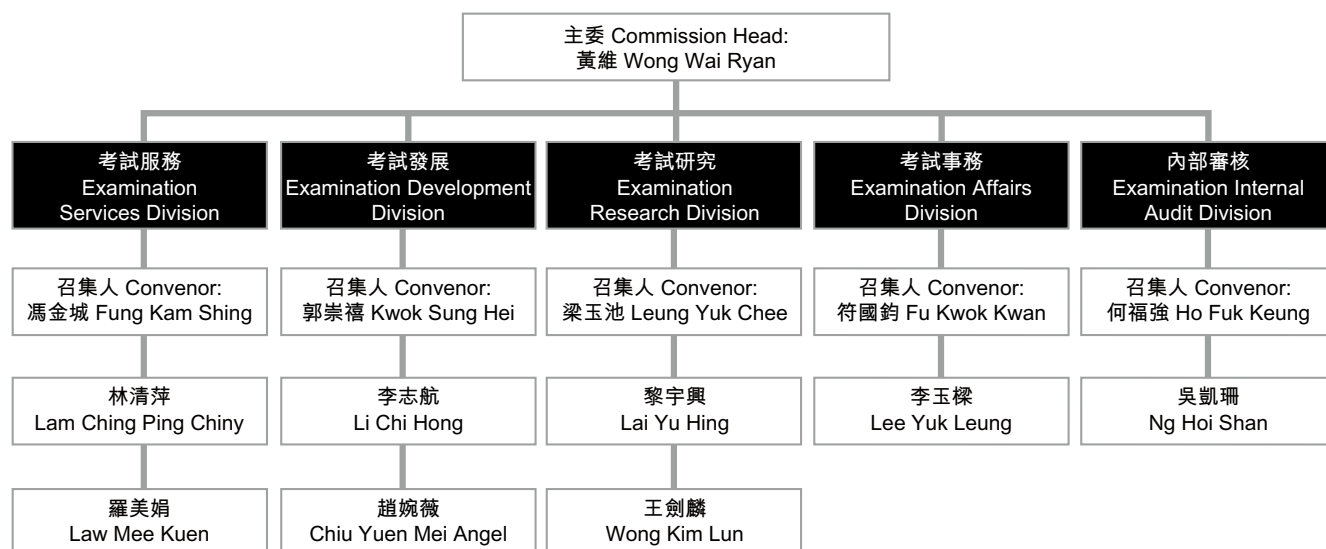

預防溺水委員會報告

Report from Drowning Prevention Commission

預防溺水委員會於本年度繼續致力發展及推動水上安全，以達致預防溺水的目標及使命。委員會仍設立下列四部，以專責分工推動預防溺水工作。

預防溺水及數據統計部

收集來自不同途徑的溺水個案數據，將其分類、分析及作出同類事故的預防措施建議後存檔「小組將建議考慮設立互聯網儲存以便將個案歸類及查閱」。並提供予有危機管理，以預防勝於救助為目標。

救生文獻及評審部

搜集、整理、儲存本港及國際相關文獻，發生事故的報告。作出研究及記錄。設計相關的評審表格及標準，以便到訪泳池及泳灘進行硬件的評審工作。希望透過有關參考資料，提升公眾人士對水上安全的意識，以預防溺水事件之發生。

救生技術研究及發展部

參考及留意世界各地之救生技術和器材發展，作出相應的技術研究並向會方提出建議購置相關先進的救生設備；以配合本港環境需要而提出修定及提升香港救生技術發展以達致國際領先水平。

水上安全研究及發展部

(一) 香港水上安全日 2021

鑒於疫情影響下，本年度 5 月 1 日由香港拯溺總會與香港游泳教師總會合辦之「香港水上安全日」因應「新型冠狀肺炎」流行，上述賽事取消。主辦單位盼望能儘快恢復舉辦是項活動。

(二) 泳池安全工作坊

總會自 2018 年起一直為各機構舉辦泳池安全工作坊，以提高及鞏固救生服務從業員及泳池管理人員在泳池管理方面的知識。今年 5 月 20 日，預防溺水委員會為港基物業管理有限公司於網上舉辦了一場「泳池安全工作坊講座」，約有 70 位管理層職員參與該講座。

(三) 二零二一年水上安全揭幕典禮

本會每年均與康樂及文化事務署聯合舉辦一連串有關水上安全的推廣活動，從而加深大眾對水上安全的了解，而本年度的「水上安全平面設計及標語創作比賽頒獎典禮」於 2021 年 8 月 17 日假康樂及文化事務署總部舉行。當日邀得康樂及文化事務署助理署長（康樂事務）陳明昌先生、總康樂事務經理（水上活動場地）李嘉美女士、香港拯溺總會水上安全主席吳家麗女士 OStJ 以及主席陳偉能 BBS, MH 太平紳士擔任頒獎嘉賓，頒發水上安全平面設計及標語創作比賽的各獎項。

Report from Drowning Prevention Commission

Drowning Prevention Commission continues to strive for promotion of water safety as it is the target and mission of drowning prevention. The Commission consists of 4 Divisions.

Drowning Prevention & Statistic Division

We are collecting data from drowning cases, through sorting and analysis; we suggest preventive measures for crisis management purpose in order to achieve the aim of "Prevention is better than cure".

Lifesaving Literature & Assessment Division

We collect, sort, and keep local and international documents and incident reports. Through investigation and record filing, we do risk assessment by visiting swimming pools and beaches with relevant assessment form and standards. We hope by identifying potential risks, we are able to increase public awareness of water safety and ultimately prevent drowning.

Rescue Technique Research & Development Division

We study overseas lifesaving techniques and equipment development so as to strengthen the lifesaving techniques in Hong Kong and to meet the international standard requirement.

Water Safety Research & Development Division

(1) Water Safety Day 2021

In view of the impact of the epidemic, the "Hong Kong Water Safety Day" co-organized by the Hong Kong Life Saving Society and the Hong Kong Swimming Teachers Association on May 1 was cancelled. The organizer hopes to resume the event as soon as possible.

(2) Water Safety Forum

In order to broaden and consolidate the knowledge of swimming pool safety in terms of facility and lifeguard service management for the pool service provider, the Water Safety Forum has been held since 2018. A virtual forum had been held for Citybase Management Service Limited via zoom on 20 May 2022.

(3) The Water Sports Safety Campaign 2021 – Graphic Design and Slogan Competition

The Hong Kong Life Saving Society jointly cooperates with the LCSD to held series of promotional activities in respect of water safety every year, aims to strengthen the understanding of water safety of the public. In this year, the water safety campaign – Graphic Design and Slogan Competition Ceremony was held in 17 August 2021 in LCSD's Headquarters.

It was our great pleasure to attain the consent of our honorary guests, Assistant Director (Leisure Services)¹ of Leisure and Cultural Services Department Mr. Horman CHAN, Chief Leisure Manager (AVU) Ms. Camay LEE, Chairman of Water Safety Council of HKLSS Ms. Jacqueline NG, OStJ, Chairman Mr. Anthony CHAN, MH, JP, to officiate the presentation ceremony of Water Safety Graphic Design and Slogan Competition.

(4) The Safety Afloat Educational Seminar 2021

The Marine Department and the Leisure and Cultural Services Department jointly organized the "2021 Water Safety Afloat Educational Seminar" which was cancelled due to COVID-19 pandemic.

(5) Water Safety Self-survival Course

On July 6, August 11, September 15, 2021 and January 28, 2022, the Commission was invited by the Hong Kong Customs and Excise Department to hold the "Water Safety Self-survival Certificate" course for new enlisted customs officers. To enhance customs officers' understanding of water safety and self-rescue, there are 4 classes in total, and about 250 customs officers obtain certificates.

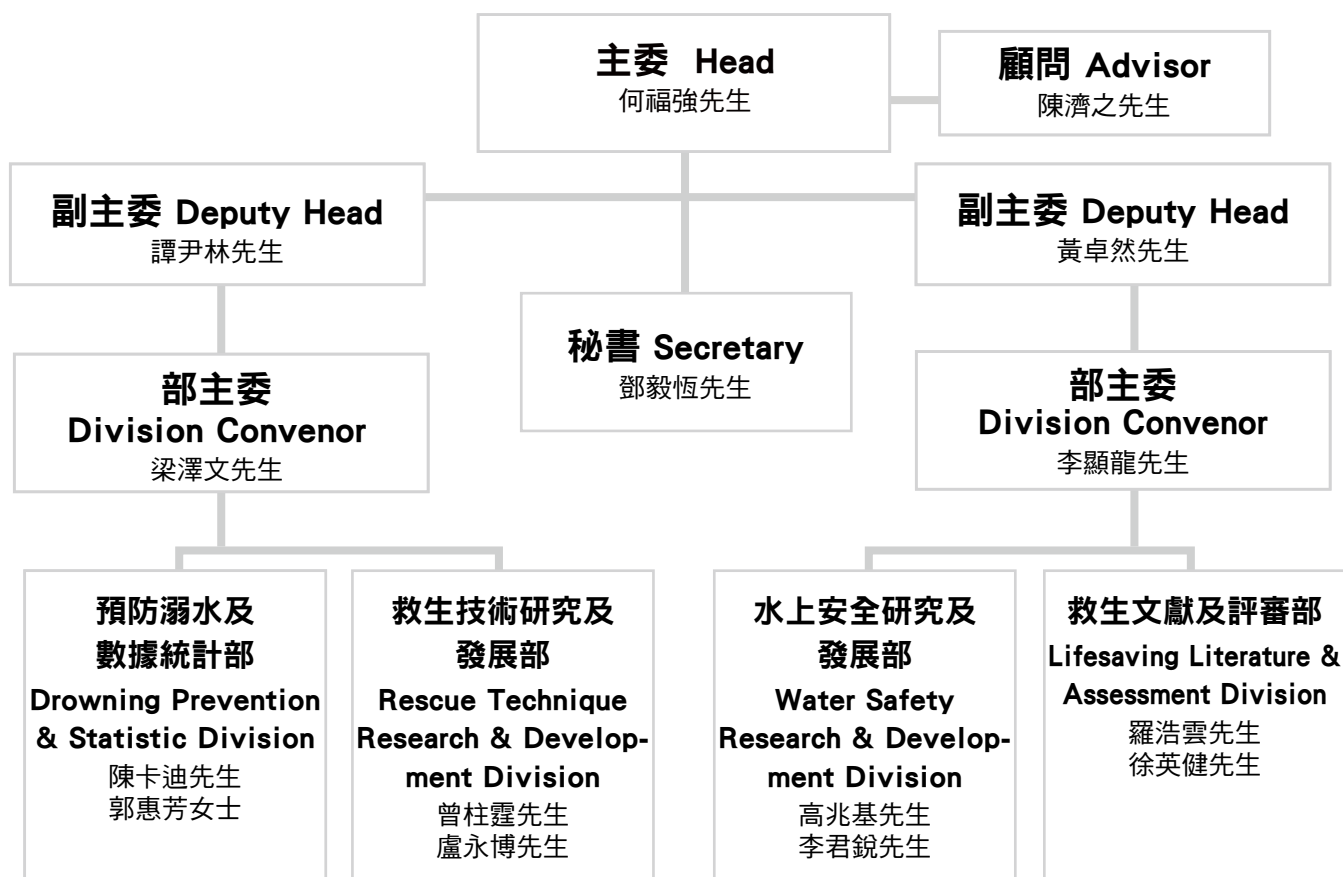
Other duties include providing water safety advices for swimming pools/beaches to the Leisure and Cultural Services Department and related organizations through the Hong Kong Life Saving Society.

Teacher Registration & Education

Since the establishment of Lifesaving Teacher Registration System, encouraging support was received by affiliated clubs and instructors. The Commission is open to the suggestions and feedbacks; through consideration and exchange of opinions, the Registration System has been more and more mature. In turn, the Registration System has been revised in 2005 so as to increase the efficacy of the teacher / instructor training. Interested candidates can participate in the continued education through nomination by their affiliated clubs under the comprehensive range of teacher / instructor training. Beginners can firstly participate in the "Examination Leaders Foundation Course" for the basic knowledge of the code of conduct, examination application procedure, leaders' skills, etc. After completion, they can be registered as "Examination Leader" and enroll in the upper training level of lifesaving teacher.

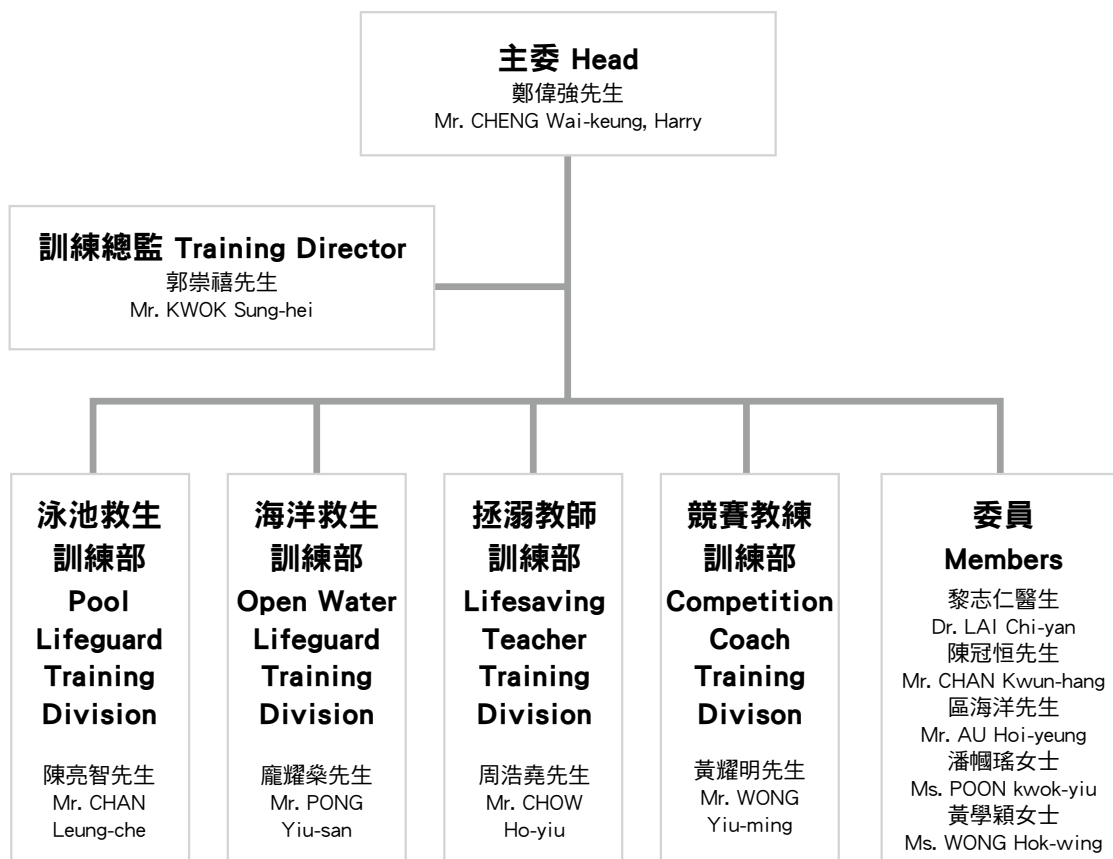

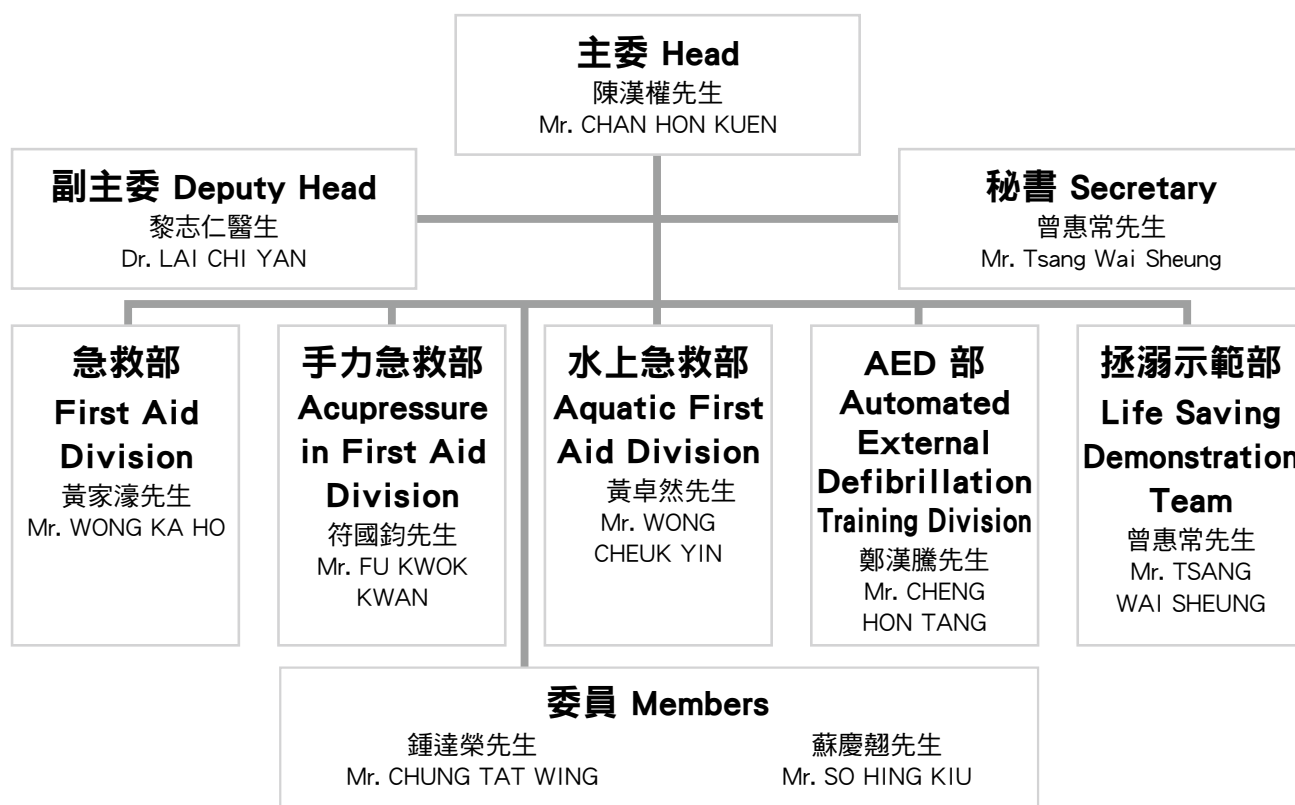

2020 水上安全主席盃

水上安全主席盃由本會前水上安全主席王賜豪醫生 SBS 太平紳士送出。此榮譽特別頒發予該年所有拯救事件中最突出的事件及救生隊伍，以表揚其發揚拯溺精神。在 2020 年的眾多拯救事件中，評審團認為康樂及文化事務署三星灣泳灘 - 鄭祥，吳寶文，吳志龍，馬三娣，石志明，簡樹堅的拯救事件最具代表性。

泳灘開放期間，六名救生員保持高度警覺，於短時間內對溺者作出拯救，並於事發時迅速採取行動及調配工作以拯救溺者，各施其職，充分發揮團隊精神，值得嘉許。

(三) 義務救生員獎勵計劃

本計劃於 1999 年起推行，其目的是希望通過實質的獎勵，以表揚在義務救生工作上表現出色的人士。由於近年社會各界對參與義務工作的重視與鼓勵，而大專院校在取錄學生時，亦積極考慮他們在課外活動的表現，相信本計劃亦有助於僱主或大專院校，以評定僱員或學生對社會服務的貢獻。

(六) 義務救生服務計劃 (適用於遊樂船河及水上活動)

此項適用於遊樂船河及水上活動的義務救生服務計劃讓各界團體 / 機構可在舉辦遊樂船河或水上活動之前，向本會要求提供義務救生服務。本會轄下之專責小組將會就個別活動的水上安全需要，提供專業及周全的義務救生服務建議，如團體 / 機構接受有關安排，本會將安排相關資歷人士提供救生服務。

義務救生服務之工作範圍

- 防止遊樂船河或水上活動中可能發生的危險事故；
- 照顧活動中的參與者和泳客的安全；
- 拯救遇事的參與者和泳客及執行救傷工作；
- 維持船上或泳灘及其周圍地方的秩序；
- 按需要分配當日的工作及有關程序。

(七) 水上安全首長巡視泳池

水上安全委員會為本會之諮詢組織，由本會首長組成，其功能是就拯溺活動、水上安全訊息的推廣及義務救生服務等向本會提供寶貴意見；而各水上安全首長亦積極參與及支持本會的各项活動。

由八十年代起每年泳季，各水上安全首長皆會巡視各區的義務救生工作，藉以鼓勵各義務救生員的士氣及實地了解他們的工作；在探訪期間，各水上安全首長亦會與有關泳池及泳灘主管交換意見，以求在救生服務上加強本會與康樂及文化事務署的配合。

Community Sports Club

The 'Community Sports Club Project' organized by the Leisure and Cultural Services Department aims to assist sports associations in promoting sports activities at the community level. Water Safety Chairman's Trophy 2020

The Water Safety Chairman's Trophy was established by Dr. Jimmy Wong, SBS, JP the former Chairman of Water Safety Council. The honor is awarded to the most outstanding rescue case of that year. The most outstanding rescue case in this year is nominated to the Trio Beach – CHENG CHEUNG, NG PO MAN, NG CHI LUNG, SHEK CHI MING and KAN SHU KIN.

3. Honorary Lifeguard Incentive Scheme

The scheme was first introduced in 1999 and aims to recognize the outstanding performance rendered by serving honorary lifeguards. In view of the growing emphasis and expectation from the public on voluntary works, the Scheme could be served as a benchmark for the prospective employers or higher educational institutions to assess the voluntary services involvement of the applicants.

A. Outstanding Honorary Lifeguards

In order to encourage enthusiastic honorary lifeguard service, for those who rendered not less than sixteen shifts are eligible to nominate for this reward. The selection criteria, among other things, were emphasized on nominee's level of participation, performance, appraisal from pool managers, as well as affiliated club's recommendations.

6. Honorary Lifeguard Services Scheme (for cruise trips and aquatics activities)

Our Society offers honorary lifeguard service for cruise trips and aquatics activities within Hong Kong Water. Our Open Water Rescue Service Team will provides advices for the water safety plan and deploy suitable honorary lifeguards to perform lifesaving duties.

Service Areas of Honorable Life Guard Services

- To avoid any aquatic related accidents in the activity;
- To safeguard participants and swimmers during the activity;
- To provide rescue service for participants and swimmers;
- To keep boats, beaches and the surrounding areas in order;
- To distribute the duties according to the agreed work schedule.

7. Goodwill Visit of Water Safety Council

Water Safety Council is the advisory body of the Society. Its objective is to provide valuable advices in respect of lifesaving programs, water safety promotion as well as honorary lifeguard services to the Society. It is formed by a group of enthusiastic councilors and advisors.

Since 80s, the members of the Water Safety Council launched goodwill visits to the honorary lifeguards services (HLGs) in various swimming pools so as to encourage the volunteers and strengthen the cooperation with the government.

In this year, the “Water Safety Goodwill Visit” was held on 22 August 2021. A group of 12 persons, including the President Mr. Steve LAU, SBS, CStJ, JP, Chairman of Water Safety Council Ms. Jacqueline NG, OStJ, Superintendent of Water Safety Council and Honorary Advisor Mr. Jimmy CHAN, Chairman Mr. Anthony CHAN, MH, JP, Vice-Chairman Dr. Patrick YEUNG, KILS, Honorary Secretary Dr. Johnnie CHAN, SBS, JP, Administration Director Mr. Stephen MA, MH, CStJ, CPM, Honorary Treasurer and Operation Director Mr. Alex LIU, Committee Members Mr. MUI Yat Yiu, Mr. David HO, Mr. Keith LEUNG attended the activities and visited three aquatic venues, which included Lei Cheng Uk Swimming Pool (service provided by Hoi Tin Athletic Association Ltd.), Lung Mei Beach (service provided by Tai Po Life Saving Club), and Hin Tin Swimming Pool (service provided by Blue Whale Life Guard Club). Councilors conveyed greetings and encouragement to the honorary lifeguards in the venues, and also presented the souvenirs to the honorary lifeguards in order to express the gratitude towards their contributions to the local life saving services.

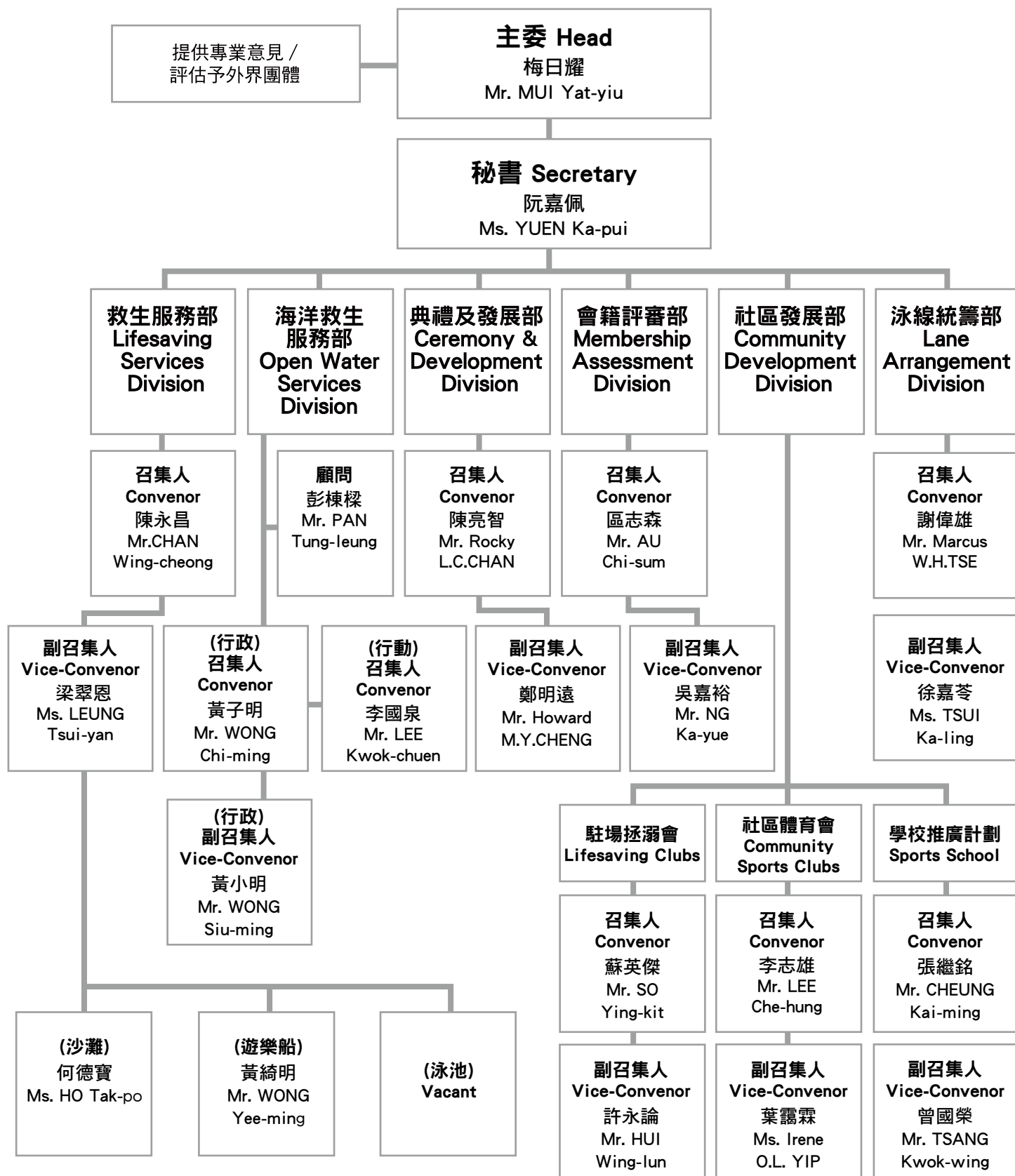

1 拯溺分齡賽

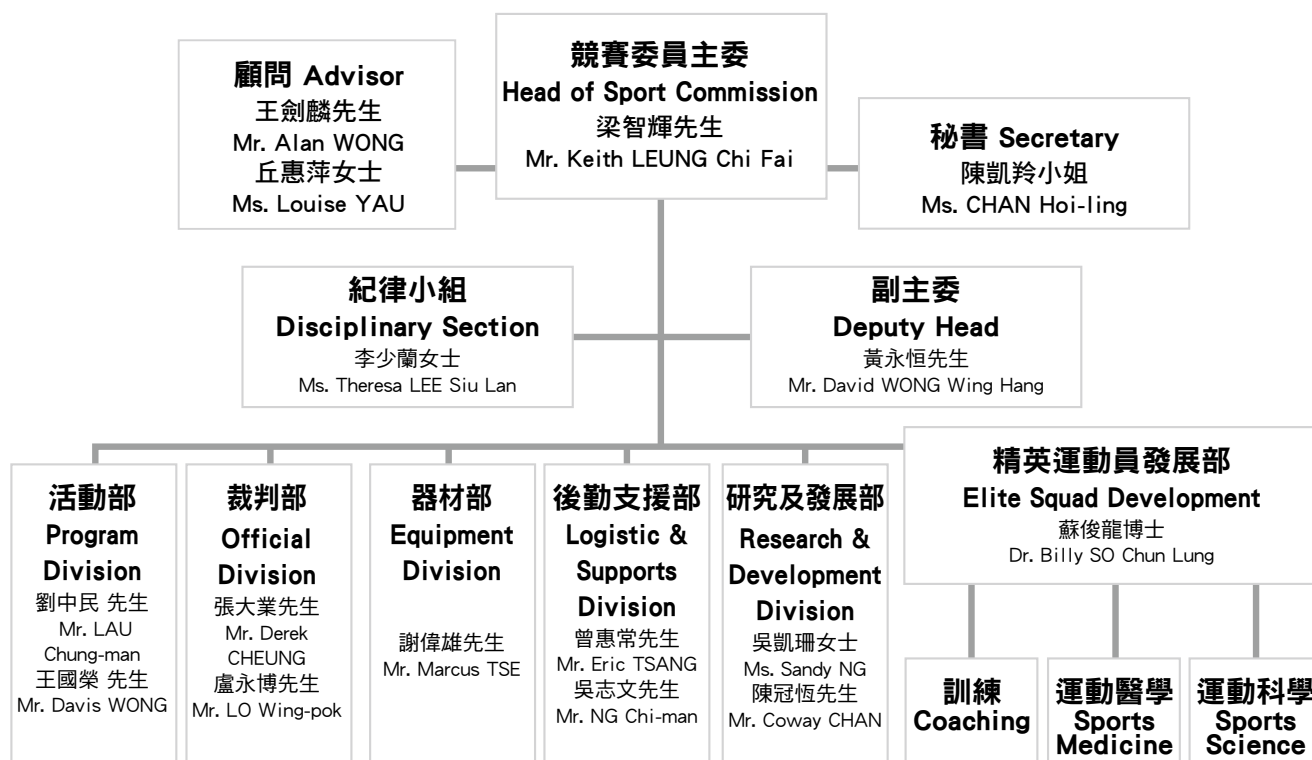
(IV) TECHNICAL OFFICIALS

Report of the Executive Committee

The Executive Committee has pleasure in submitting their annual report and the accompanying statement of the Society's audited financial statements for the financial year ended 31st March, 2022.

PRINCIPAL ACTIVITY

The principal activity of the Society is promoting lifesaving movement and concept of water safety for the Hong Kong Community by means of organizing examinations, competitions, training as well as providing lifesaving services. During the financial year under review, there was no significant change in such activity.

BUSINESS REVIEW

The objects of the Society are primarily aiming to combating aquatic-related accidents, encouraging people to participate in advocating water safety, lifesaving training, examinations and competitions so as to arouse the public awareness on water safety, and to select athletes to represent Hong Kong at regional and international lifesaving competitions.

The Society implements the objects as directed by the Executive Committee through seven specific commissions, namely Drowning Prevention Commission, Education Commission, Examination Commission, Medical Commission, Services & Development Commission, Business Commission and Sport Commission. With the support of the Secretariat office, in coordination with numerous volunteers, activities were organized according to approved budgets and annual plan. Some of the activities, like examinations, training courses, seminars, competition, Hong Kong Team training and participation of overseas events, honorary lifeguard services, dinners and ceremonies, etc., were cancelled due to COVID-19.

The Society continues to enjoy a harmonious relationship with its members and has worked steadily to improve channels for communication and feedback. The primary channel for this is via the annual meeting with venue based lifeguard clubs meeting conducted by Services & Development Commission in order to collect members' views on specific issues.

There are currently 30 Venue Based Lifeguard Clubs in swimming pools, 10 Venue based Lifeguard Clubs in beaches, 33 Community Sports Clubs among 114 affiliated clubs under our Society. With the tremendous efforts rendered by these clubs, there were 39,102 nos. of lifesaving examination enrollments in 2021/22, with a total of 14,726 lifesaving awards issued in 2021/22. Meanwhile, 135 training courses were held in 2021/22 with a total of 1925 participants. According to the Hong Kong Monthly Digest of Statistic (December 2020) – “Fertility Trend in Hong Kong, 1981 to 2019” issued by Census and Statistics Department, the annual number of live births in Hong Kong dropped steadily from 86,751 in 1981 to 46,796 in 2004 and rebound to 70,875 in 2007. The age requirement for Bronze Medallion examination is at least 13 years old, while for lifeguard awards is 16 years old. Therefore, it is estimated that the rebound birth rate would affect the participation rates in these few years.

The Society is mainly funded by Sports Subvention Scheme administered by Leisure and Cultural Services Department (LCSD). The subvention for local and overseas competitions is a basic block grant, but is not sufficient to cover all the expenses incurred. The excess expenditure will be met by the Society's own fund. The financial position of the Society is generally sound and stable.

In order to promote lifesaving and water sports, the Society organizes Age Group Lifesaving Competitions, Hong Kong Open Lifesaving Championships, Hong Kong Life Saving Marathon, New Year Winter Swimming Lifesaving Championships, etc. Meanwhile, the Society usually supports the Hong Kong Schools Sports

Federation in organizing the “All HK Inter-Secondary Schools Life Saving Competition” every year so as to provide a wider spectrum of student-athletes, however, due to the COVID-19 in 2021, several competitions were cancelled.

For lifesaving sport development, since the Society has achieved an Elite Vote score of 7.9 points during the two-year evaluation period of 2017-2018, it was qualified to receive funding from Hong Kong Sports Institute of the Tier B Elite Vote Support System (EVSS) for four-year 2019 – 2022 funding cycle, subject to review by the end of 2022. In 2021/22, the Society continued to obtain EVSS fund of a maximum of \$1.5m p.a. under Tier B EVSS. It greatly enhanced the elite training programme as funding is eligible for hiring of Head Coach, local and overseas Hong Kong Team training and competition, purchase of sports equipment funds, etc.

As the epidemic has been subsiding, the demands for the honorary lifeguard service from other organizations’ activities were resumed. The number of shifts for 2021/22 was 286. Nevertheless, it is foreseeable that the repair and maintenance costs for lifesaving craft and equipment are still rising, e.g. inflatable rescue boats, jet skis, rescue canoes and patrol boards, and we would continue to train up qualified lifeguards in order to fulfill the demand in future.

It is important to secure adequate public liability insurance for the Society’s activities, services and related affairs. We have secured not only public liability insurance for all activities, but also all voluntary helpers, examiners, assessors and participants are protected under the coverage of Group Personal Accident Insurance Policy. Additionally, the Society has also secured an Association Liability Insurance since 2017/18 in order to cover for any possible association professional indemnity, officer’s indemnity and entity employment practices indemnity.

The Society was granted the status as a charitable institution since 10 March 1967, and is a tax exempted organization under Section 88 of the Inland Revenue Ordinance. The charitable status of the Society was reviewed by the Inland Revenue Department in 2022 and the status remains unchanged.

The Accounting Procedures and Procurement Guidelines of the Society have been fully implemented since 2017/18. The Society places great emphasis on good governance in following the Guidelines; however the increasing workload of office staff was noted.

FINANCIAL STATEMENTS

The financial performance of the Society for the year ended 31\$ March 2022 is set out in the financial statements prepared by the Auditor.



Opinion

We have audited the financial statements of The Hong Kong Life Saving Society ("the Society") set out on pages 4 to 22, which comprise the statement of financial position as at 31st March, 2022, and the statement of income and expenditure, statement of profit or loss and other comprehensive income, statement of changes in funds and reserve, statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the financial statements give a true and fair view of the financial position of the Society as at 31st March, 2022, and of its financial performance and its cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standard for Private Entities ("HKFRS for Private Entities") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and have been properly prepared in compliance with the Hong Kong Companies Ordinance.



THE HONG KONG LIFE SAVING SOCIETY NOTES TO THE FINANCIAL STATEMENTS

(1) STATUS AND INFORMATION OF THE SOCIETY

The Hong Kong Life Saving Society (the Society), a charitable institution approved under Section 88 of the Inland Revenue Ordinance, is a company limited by guarantee under the Hong Kong Companies Ordinance. The Society's registered office is situated at 21/F., Caltex House, 258 Hennessy Road, Wanchai, Hong Kong.

The objectives of the Society are to develop and promote technical education in water safety and life saving and to organize activities and programmes for members.

(2) BASIS OF PREPARATION

The financial statements have been prepared in accordance with Hong Kong Financial Reporting Standard for Private Entities ("HKFRS for PEs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention except for long-term listed investments classified as available-for-sale financial assets which are stated at fair value as explained in the accounting policies set out below.

(3) SIGNIFICANT ACCOUNTING POLICIES

(a) Property, plant and equipment and depreciation

Property, plant and equipment represent Club-House, furniture, fixtures and equipment, Tin Hau and other statues and rescue equipment and are stated in the statement of financial position at cost less accumulated depreciation and impairment losses, if any.

Depreciation is provided to write off the cost of property, plant and equipment over their estimated useful lives, at the following rates per annum on reducing balance method:

Club House	10%
Furniture, fixtures and equipment	20%
Tin Hau Statues	10%
Rescue equipment - fully depreciated on acquisition during the year

(3) SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

(b) Long-term investments

Long-term investments are investments in securities held on a continuing basis for long-term purpose. They are “available-for-sale financial assets” and are stated at fair value at the end of each reporting period. Changes in fair value of long-term investments are recognized in other comprehensive income and accumulated separately in changes in funds and reserve as fair value for long-term investments reserve. Investments in equity securities that do not have a quoted market price in an active market and whose fair value cannot be reliably measured are stated at cost less impairment loss if any. When an individual investment is considered to be impaired, the cumulative loss that had been recognized directly in equity is removed from equity and is recognized in the statement of income and expenditure.

For investment in equity securities, if impairment losses recognized in the statement of income and expenditure are subsequently decreased, they are not reversed through the statement of income and expenditure and any subsequent increase in the fair value is recognized directly in equity. For investment in debt securities, if impairment losses recognized in statement of income and expenditure are subsequently decreased, they are reversed through the statement of income and expenditure.

(c) Impairment of assets

At the end of each reporting period, the Society reviews the carrying amounts of its assets to determine whether there is any indication that those assets have suffered an impairment loss. If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognized as an expense immediately, unless the relevant asset is carried at a revalued amount under another standard, in which case the impairment loss is treated as a revaluation decrease under that standard.

When an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognized for the asset in prior years. A reversal of an impairment loss is recognized as income immediately, unless the relevant asset is carried at a revalued amount under another standard, in which case the impairment loss is treated as a revaluation increase under the other standard.

(d) Related entities

For the purpose of these financial statements, related party includes a person and entity as defined below:

- (a) A person or a close member of that person's family is related to the Society if that person:
 - (i) is a member of the key management personnel of the Society or of a parent of the Society;
 - (ii) has control of the Society; or
 - (iii) has joint control or significant influence over the Society or has significant voting power in it.
- (b) An entity is related to the Society if any the following conditions applies:
 - (i) the entity and the Society are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to each others);
 - (ii) either entity is an associate or joint venture of the other entity (or a member of a group of which the other entity is a member);
 - (iii) both entities are joint ventures of a third party;
 - (iv) either entity is a joint venture of a third entity and the other entity is an associate of the third entity;
 - (v) the entity is a post-employment benefit plan for the benefit of employees of either the Society or an entity related to the Society. If the Society is itself such a plan, the sponsoring employers are also related to the plan;
 - (vi) the entity is controlled or jointly controlled by a person identified in (a); or
 - (vii) a person identified in (a)(i) has significant voting power in the entity.

(e) Recognition of income

- (i) Membership subscription, donation and subvention are accounted for on the basis of actual cash received of the current year's programmes and activities.
- (ii) Revenue from seminars, examinations, functions and programmes are recognized upon completion of services provided.
- (iii) Interest income from bank savings account and time deposit account are recognized on cash basis.
- (iv) Dividend income from listed investments is recognized when the share price of the investment goes ex-dividend.

(f) Inventories

Inventories are valued at the lower of cost and net realizable value. In arriving at net realizable value an allowance has been made for deterioration and obsolescence.

(g) Receivables

Receivables are initially recognized at transaction price and thereafter stated at amortised cost less any impairment losses for bad and doubtful debts, except where the receivables are interest free advances without any fixed repayment terms or that effect of discounting would be immaterial, then they are stated at cost less any impairment losses for bad and doubtful debts. When receivables are considered to be impaired, impairment losses are recognized and reversed in the statement of income and expenditure.

(h) Payables

Payables are initially recognized at transaction price and thereafter stated at amortised cost except where the payable are interest free advances without any fixed repayment terms or the effect of discounting would be immaterial, then they are stated at cost.

(i) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition.

(j) Leases

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership of the leased asset to the Society. All other leases are classified as operating leases.

Rights to assets held under finance leases are recognized as assets of the Society at the fair value of the leased property or, if lower, the present value of the minimum lease payments at the inception of the lease. The corresponding liability to the lessor is included in the statement of financial position as a finance lease obligation. Lease payments are apportioned between finance charges and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are deducted in measuring profit or loss. Assets held under finance leases are included in property, plant and equipment, and depreciated and assessed for impairment losses in the same way as owned assets.

Rental payable under operating leases are charged to profit or loss on a straight-line basis over the terms of the relevant lease.

(k) Translation of foreign currencies

Monetary assets and liabilities denominated in foreign currencies at the year end are translated at foreign exchange rates ruling at the end of the reporting period. Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Differences on foreign currency translation are dealt with in the income and expenditure statement.

(l) Employee benefits

Contributions to Mandatory Provident Funds as required under the Hong Kong Mandatory Provident Fund Schemes Ordinance are recognized as an expense in the statement of income and expenditure as incurred.
